- **Submission Process** – Online at <http://mc.manuscriptcentral.com/jsbm>
- **Manuscript Specifications** - Manuscripts should not exceed 20 pages, double-spaced (excluding tables and references). Occasionally, a longer manuscript that presents forefront research on small business and entrepreneurship will be accepted for review. These longer manuscripts should not exceed 30 pages (excluding tables and references). Submission of only one copy is required online. Readers include academics (professors and researchers), business practitioners and administrators.
- **Review Process for the calendar year 2010**
 - **Acceptance Rate** – 8.20%
 - **Invited Articles** -2.5% (13 of 514 total manuscripts received)
 - **Type of Review** – Double-blind
 - **No. of External Reviewers** – 289
 - **No. of In-House Reviewers** - 160
 - **Time to Review (weeks to first decision)** – 9-10 weeks
 - **Reviewer's Comments** – All authors obtain a copy of the reviewer's comments in the decision letter

Mission Statement: All manuscripts should address research issues in a rigorous way using qualitative, quantitative or a combination of these techniques; however, JSBM encourages the incorporation of pragmatic advice for practitioners based on the research results.
